## **ORDINANCE NO. 2016-02**

AN ORDINANCE RELATING TO REZONING OF CERTAIN PROPERTY LYING WITHIN THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PIONEER VILLAGE, BULLITT COUNTY, KENTUCKY AS FOLLOWS:

<u>SECTION ONE:</u> The recommendation of approval made by the Bullitt County Planning Commission concerning the rezoning request of Brookland Realty, LLC, from (B-1) Highway Business to (B-2) Central Business is approved for the property described as follows:

Beginning at an iron pin in the west right of way of Old Kentucky Hwy. 61 at the northeast corner of Brookland Realty, LLC, (Deed Book 751 Page 597), thence with the north property line of Brookland Realty, LLC, (Deed Book 751 Page 597) N 50° 58′ 00″ W 186.54′ to an iron pin in the east right of way of New Ky.
